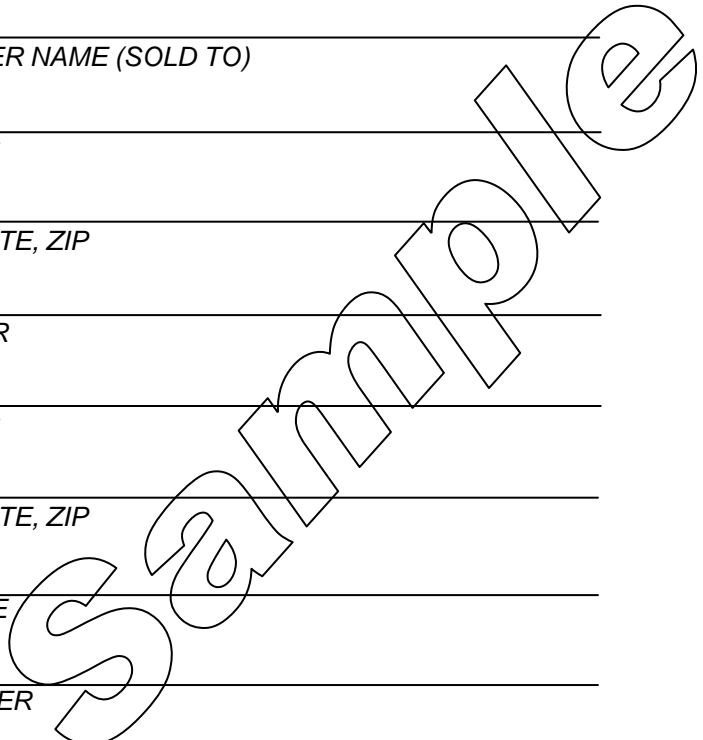

Spec-Rite Designs, LLC will continue to design and manufacture our line of ceiling hung DesignRite Partitions and our warranty for ceiling hung partitions will read as follows:

Spec-Rite Designs, LLC warrants its products to be free from defects in workmanship for a period of two (2) years from the date of purchase when properly stored, handled, installed and maintained under normal use.

Further, the phenolic material is warranted by the panel manufacturer through Spec-Rite Designs, LLC as its Distributor for a period of fifteen (15) years from date of purchase not to delaminate or warp. Please Note:

Improper installation will be defined as any and all installations where the support bracing isn't reinforced prior to installing the partitions. Without providing additional support bracing, the partitions will have a tendency to sway, causing the potential for warping and potentially cause irreparable damage. This damage is not based on the design or manufacturing of the partitions, it is a direct result of improper support. The warranty will become null and void should any panel damage occur due to the lack of support and improper installation of the DesignRite Partitions.
